Part A: Pupil premium strategy plan

Statement of intent

At Miers Court Primary School, we ensure that our Pupil Premium Grant is used to provide a range of teaching and learning opportunities for our children, closely matched to their needs. Our aim is to narrow the gap between pupils eligible for Pupil Premium and their peers and to eliminate barriers to learning and progress, including that of our higher attainers; these are seen as barriers to be overcome - not excuses for poor attainment or lack of progress.

We consider the challenges faced by vulnerable pupils, such as those who have a social worker and young carers. The activity we have outlined in this statement is also intended to support their needs, regardless of whether they are disadvantaged or not.

High-quality teaching is at the heart of our approach, with a focus on areas in which disadvantaged pupils require the most support. This is proven to have the greatest impact on closing the disadvantage attainment gap and at the same time will benefit the non-disadvantaged pupils in our school. Implicit in the intended outcomes detailed below, is the intention that non-disadvantaged pupils' attainment will be sustained and improved alongside progress for their disadvantaged peers.

Our strategy is also integral to wider school plans for education recovery, notably in its targeted support through tutoring for pupils whose education has been worst affected, including non-disadvantaged pupils.

Our approach will be responsive to common challenges and individual needs, rooted in robust diagnostic assessment, not assumptions about the impact of disadvantage. The approaches we have adopted complement each other to help pupils excel. To ensure they are effective we will:

- ensure disadvantaged pupils are challenged in the work that they're set
- act early to intervene at the point need is identified
- adopt a whole school approach in which all staff take responsibility for disadvantaged pupils' outcomes and raise expectations of what they can achieve

Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge number	Detail of challenge
1	Financial constraints which may mean that eligible pupils are unable to access educational visits and other extra-curricular opportunities and the resultant impact on attendance and self-esteem.
2	<p>Pupils may not have had access to books or have had them read to them at home, or have opportunities to read regularly with an adult. This has been exacerbated by the Covid-19 pandemic and remains an issue for some families.</p> <p>This negatively impacts on their development as readers and the development of positive attitudes towards reading.</p>
3	Some pupils lack confidence, self-esteem and/or resilience which results in them being unwilling to take a chance in case they get their work wrong. They do not see making mistakes as part of the learning process.
4	Additional support needs in the classroom which may impact upon eligible pupils' ability to be able to remain focused and access learning.
5	<p>Some pupils are suffering from additional anxiety and mental health concerns as a result of the pandemic. The number of contacts from parents and referrals by teachers has increased significantly.</p> <p>Our disadvantaged children have been disproportionately impacted. Partially due to a lack of enrichment opportunities during school closure.</p>
6	Attendance: some children have low attendance and this impacts on their learning. This has significantly increased for some of our more vulnerable families as a result of the Covid-19 pandemic.
7	<p>Baseline assessments in September in KS2 evidenced a clear loss of learning for many pupils.</p> <p>Assessments, observations and discussions have suggested that this is more prevalent amongst our disadvantaged pupils.</p>
8	<p>Baseline assessments for Years R, 1 and 2 show the impact of the loss of learning in speaking, listening, phonics, reading and writing.</p> <p>Assessments, observations and discussions have suggested that this is more prevalent amongst our disadvantaged pupils.</p>

Intended outcomes

Part B: Review of outcomes in the previous academic year

Pupil premium strategy outcomes

This details the impact that our pupil premium activity had on pupils in the 2021 to 2022 academic year.

EYFS Outcomes for Good Levels of Development

All pupils 66.0%. Pupil Premium 37.5% compared to Non-Pupil Premium 71.4%

All EYFS areas are monitored in the pupil progress meetings. PSED and Communication and Language will be a continuing focus during the next academic year.

Key Stage 1 Outcomes

All pupils Year 1 Phonics Screening expected standard = 74.5%

KS1 SATS – expected standard

All pupils Combined reading, writing, maths at the expected standard = 53.3% (Reading = 64.4%; Writing = 55.6% and Maths = 66.7%). The small cohort of Pupil Premium Eligible pupils outperformed their Non-Pupil Premium Eligible classmates. Maths remains a key area of development in KS1 for the coming academic year.

Key Stage 2 Outcomes

All pupils Combined reading, writing and maths at the expected standard = 59.4% (National 59%). There is a gap between Pupil Premium outcomes and non pupil premium outcomes.

From September 2022, pupil progress meetings across Y3-6, will look in greater detail at individual subject and combined outcomes for children, setting specific targets as necessary.

Our assessment of the reasons for these outcomes points primarily to on-going Covid-19 impact, which disrupted all of our subject areas to varying degrees over the past few years. As evidenced in schools across the country, school closure was most detrimental to our disadvantaged pupils, and they were not able to benefit from our pupil premium funded improvements to teaching and targeted interventions to the degree we had intended. The impact was mitigated by our resolution to maintain a high-quality curriculum, including during periods of partial closure, which was aided by the use of online resources such as those provided by Oak National Academy. Although, this academic year, many gaps in learning were addressed the pandemic has had a lasting impact on learning.

Our assessments and observations indicated that pupil behaviour, wellbeing and mental health were significantly impacted over the last year, primarily still due to COVID-19-related issues. The impact was particularly acute for disadvantaged pupils. We used pupil premium funding to provide wellbeing support for all pupils, and targeted interventions where required. We are building on that approach with the activities detailed in this year's plan.

Overall attendance in 2021/22, was 92.59% for all students which is in line with National Data. For our pupil premium students, attendance was 86.75%. We continue to challenge low attendance and work closely with the Attendance Service to support families.
